Evergreen creates and protects sustainable mountain biking opportunities in WA State. We accomplish this through four primary programs: Trail Construction, Volunteer Trail Maintenance, Education and Community Building & Advocacy.

TRAIL CONSTRUCTION PROJECTS: In 2018, Evergreen's total construction work encompassed 79.1 miles of new trail across Washington State. We opened 29.85 miles of new trails, including: 18 miles at Raging River, 1.1 miles at Tiger Mountain, 7 miles at Chickadee/Sun Mountain, .5 mile at Dockton Forest, 6 miles at No2 Canyon, 1 mile at Seabrook, 1 mile at Summit Ridge, and 25 mile at the North Bend Pump Track. We also began construction on 5 new trail projects across WA, totaling 49.25 miles when complete.

COMMUNITY BUILDING & ADVOCACY: Evergreen hosted 32 events across all chapters, and 223 rides across all chapters, as well as other community building services, such as and trail etiquette education days/surveys, for mountain bikers and other trail users across all 8 chapters. Our annual "Take a Kid Mountain Biking Day" in early October drew an estimated 400 participants. In total, our events engaged an estimated 12,000 mountain bikers and other visitors. We collaborated with other recreation and conservation organizations on WA State recreation policy development, multi-use trail project planning, and tourism and/or economic development initiatives. Advocacy work included multiple e-newsletters and advocacy alerts to engage our members, supporters, and followers in public land policy, protection, and access issues, as well as project development opportunities; updating our website project pages to inform members and donors what projects are under-way as a result of their support, volunteer appreciation celebrations, new trail opening events, site tours for donors, members meetings, as well as festivals and races across the state. We also hosted a Legislative Awareness Day for recreation policy and funding, with just shy of 30 attendees. In addition, we attended the Washington Wildlife and Recreation Coalition Legislative Day with 5 staff to support

EDUCATION: Evergreen organized 222 group rides, classes, and clinics for mountain cyclists of all ages and skill levels. In 2018, our Cranksisters Women's program organized 94 group rides, engaging 439 female riders. In total, 1,318 students enrolled in our classes and clinics. Many of our rides are targeted to specific groups such as beginners, women, children and teens, and participants may join group rides free of charge (Evergreen membership is not required). 313 youth enrolled in our dirt camps. Our train-the-trainer program for instructors and ride leaders included 50+ instructors, and we provided 4 Trail School classes, engaging 96 students on the fundamentals of sustainable trail construction. In 2018, we opened one additional education program, to meet growing demand. We began hosting summer classes at Squilchuck Park for riders in the greater Wenatchee area, specifically to reach underserved youth. Combined with our youth Dirt Camp programs at Duthie Hill, Swan Creek, and our ongoing adult clinics and private lessons at Beacon Hill in Spokane, we're seeing continued interest in growing mountain bike education services. We hosted 12 scholarships for disadvantaged youth in the Tacoma Dirt Camp Program in 2018, in partnership

Form 990, Part VI, Section A, Line 4 - Evergreen adopted new bylaws in spring 2018 to respond to the organization's growth in chapters and projects in recent years. Primary changes included: -Restructure the Board to cap board members to 15. Former bylaws required the President of each chapter to also be on the statewide Board. With growing chapters across the state, this was leading to Board growth and made it more difficult to achieve quorum at Board meetings. To address the former unlimited board positions, the new bylaws now require 2 representative from 6 new defined regions in Washington State, as well as 3 at large positions. This ensures a more stable board structure and limits its size as the organization adds more chapters. -Addition of Board contract review requirements for any new contract over \$20,000 for new clients. This was added to ensure adequate Board oversight on project contracts across the State. -Elimination of conflict of interest clause for Chapter Council members who are also Evergreen employees. This was needed to address the organizations growth in multiple regions and former or current volunteer board members becoming Evergreen employees. As chapters are growing, Evergreen is hiring new employees across the State and needed to revise this former restriction to be able to hire qualified staff. All employees who also serve on the State Board are not able to attend executive sessions related to employee hiring, termination, compensation or benefits, in order to protect any conflict of interest concerns.

Form 990, Part VI, Section B, Line 11b - Copies of Form 990 are presented to Management and the Board in draft form. The form is reviewed; then the contract accountant and staff address any questions that come up.

Final Compensation approval is conducted in Executive Session at Board meeting. Last adjustment was made in February 2019.

In 2018, evergreen hosted 514 volunteer work parties in national forests, state parks, department of natural resources' state forests, as well as county and city parks throughout the state. Work parties were held with a recorded 4,829 volunteers who signed in and contributed a total of 29,685 hours of volunteer work on more than 650 miles of trail.
